This Writ Petition has been filed directing the respondent to consider the petitioner's representation dated 23.04.2023 and grant permission to the petitioner in order to conduct the cultural programme (Adal Padal Nigalchi) which is schedule to be held on 03.05.2023 at 06.00 PM to 11.00 PM in Ongaliamman Temple situated at Karai Ellappalayam, Elavamalai Post, Erode District-638 316.

The learned counsel appearing for the petitioner submitted that in order to conduct the Cultural dance programme (Adal Padal Nigalchi) which is schedule to be held on 03.05.2023 at 06.00 PM to 11.00 PM in Ongaliamman Temple situated at Karai Ellappalayam, Elavamalai Post, Erode District - 638 316, the petitioner has sent a representation dated 23.04.2023 to the respondent. It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 23.04.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
