This Writ Petition has been filed directing the respondent to give for permission to conduct the cultural programme (Adal Padal Nigalchi) in the event of Sri Mariyamman Kovil at Marukhampatti, Pazhayur, Pennagaram, Dharmapuri District on 03.05.2023 between 06.00 PM to 11.00 PM based on the petitioner's representation dated 07.04.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme (Adal Padal Nigalchi) in the event of Sri Mariyamman Kovil at Marukhampatti, Pazhayur,, Pennagaram, Dharmapuri District on 03.05.2023 between 06.00 PM to 11.00 PM, the petitioner has sent a representation dated 07.04.2023 to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 07.04.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
