**ORDER**

This Writ Petition has been filed directing the respondent to grant permission and Police Protection to conduct Cultural Programme (Adal Padal Nigalchi) in the event of Poolappalayam Village Arulmigu Sree Kongu Mariyamman Temple Festival at Bhavani Taluk, Erode District on 05.05.2023 between 06.00 PM to 11.00 PM by considering the Petitioner's representation dated 21.04.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme (Adal Padal Nigalchi) in the event of Poolappalayam Village Arulmigu Sree Kongu Mariyamman Temple Festival at Bhavani Taluk, Erode District at 06.00 PM to 11.00 PM, the petitioner has sent a representation dated 21.04.2023 to the respondent. It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 21.04.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
