2.The grievance of the revision petitioner, who is the fifth respondent in the writ petition is that the observation made by this Court in paras 5 and 6 of the above order that enquiry has been conducted against the President / review petitioner and findings have been recorded as against the

The other portion of the order dated 28.02.2023 passed by this Court in W.P.No.5851 of 2023 remains unchanged. The review application is closed accordingly.
