COMMON ORDER

The Award passed by the Principal Labour Court, Chennai in I.D.No.113 of 2008, dated 15.03.2016, is under challenge in the present writ petitions.

The learned counsel for the petitioners submit that, as against the award passed in I.D.No.113 of 2008, dated 15.03.2016, the Management of Greeta Musical Instruments Manufacturing and Exports Private Limited has filed a writ petition before this Court in W.P.No.26006 of 2019 and the same was dismissed. Aggrieved by the same, the management has filed a writ appeal in W.A.No.280 of 2023 and the said writ appeal was also
