This writ petition has been filed for the issuance of a Writ of Mandamus directing the fourth respondent to take appropriate action against the fifth respondent based upon the fourth respondent proceedings dated 20.02.2023 and 27.03.2023 passed in Na.Ka.No.456/2023/F2 and to remove the illegal and unauthorised constructions made by fifth respondent in Town S.F.No.1844, total extent of 436 Sq.ft (26'x16'), Plot No.EWS-52, Ward No.4, Block No.33, Thamarai Nagar, Tiruvannamalai Town, Tiruvannamalai District by putting the steps and entrance and sunshade in the public street.
