ORDER

This writ petition has been filed to direct the respondents not to interfere with the running of petitioner's bunk shop at 150, Montieth Road, Egmore, Chennai-600 008, wherein the petitioner is selling Tea, Coffee, Snacks, sandwich, cool drinks and other allied food items till the Town Vending Committee is formed as per the provisions of the Street Vendors (Protection of Livelihood Regulation) Act, 2014.

2. Today, when the matter is taken up for hearing, Mr.E.C.Ramesh, learned standing counsel for Corporation would submit that the petitioner's representation will be considered and disposed of within a period of four weeks.

3. Recording the same, this Writ Petition stands disposed of with a direction to the first respondent to consider and pass appropriate orders on

the representation of the petitioner dated 10.04.2023 within a period of four weeks from the date of receipt of a copy of this order. Till the disposal of the representation, no coercive action shall be taken against the writ petitioner. Connected miscellaneous petition is closed. There shall be no order as to costs.
