ORDER

This writ petition has been filed to direct the respondents not to interfere with the running of petitioner's bunk shop at Near No.15, Kakani Towers and Uthamar Gandhi Road, Wallace Garden 2nd Street, Chennai-600 006, wherein the petitioner is selling Tea, Coffee, Snacks, Tiffen and other food items therein by using LPG gas stove till the Town Vending Committee is formed and also to consider and dispose of the petitioner's representation dated 12.04.2023 as per the provisions of the Street Vendors (Protection of Livelihood Regulation) Act, 2014.

2. Today, when the matter is taken up for hearing Mr.E.C.Ramesh, learned standing counsel for Corporation would submit that the petitioner's representation will be considered and disposed of within a period of four weeks.
