ORDER

The Writ Petition has been filed to direct the respondent to consider the petitioner's representation dated 22.04.2023 in seeking permission for conducting cultural programme (Adal Padal) for the temple festival of Arulmigu Padavettamman Temple at Perumanallur Colony, Perumanallur Post, Pallipattu Taluk, Tiruvallur District scheduled to be held on 17.05.2023 between 6 pm to 10 pm.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme on 17.05.2023 from 06.00 PM to 10.00 PM in Arulmigu Padavettamman Temple situated at Perumanallur Colony, Perumanallur Post, Pallipattu Taluk, Tiruvallur District, the petitioner has sent a representation dated 22.04.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.
