ORDER

This Writ Petition has been filed to direct the respondent to give permission and police protection to conduct Cultural Programme (Adal Padal Nigalchi) in the event of Kannivadi Village, Erachapadi Arulmigu Sree Varadharaja Perumal Temple Festival at Dharapuram Taluk, Tiruppur District on 24.05.2023 between 06.00 P.M to 11.00 P.M by considering the petitioner's representation dated 28.04.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of ***Kannivadi Village, Erachapadi Arulmigu Sree Varadharaja Perumal Temple Festival at Dharapuram Taluk, Tiruppur District on 24.05.2023 between 06.00 P.M to 11.00 P.M, the petitioner has sent a representation dated 28.04.2023*** to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner dated 28.04.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is Allowed. No costs.
