The Writ Petition has been filed to direct the respondent to give permission to conduct cultural programme (Adal Padal Nigalchi) in the event of Idumbavanam Melavadiyakadu Arulmigu Sree Seenivasa Ayyanar Swamy Temple Festival at Muthupettai Taluk, Tiruvarur District on 13.05.2023 between 06.00 p.m to 11.00 p.m by considering the petitioner's representation dated 02.05.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme on 13.05.2023 from 06.00 PM to 11.00 PM in Idumbavanam Melavadiyakadu Arulmigu Sree Seenivasa Ayyanar Swamy Temple situated at Muthupettai Taluk, Tiruvarur District, the petitioner has sent a representation dated 02.05.2023 to the respondent.
