This Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct Cultural Programme (Adal Padal Nigalchi) in the event of Jari Kondalampatti, Ambedkar Street Arulmigu Sree Muthu Mariyamman Temple Festival at Salem South Taluk, Salem District on 22.05.2023 between 06.00 P.M to 11.00 P.M by considering the petitioner's representation dated 29.04.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of ***Jari Kondalampatti, Ambedkar Street Arulmigu Sree Muthu Mariyamman Temple Festival at Salem South Taluk, Salem District on 22.05.2023 between 06.00 P.M to 11.00 P.M, the petitioner has sent a representation dated 29.04.2023*** to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner dated 29.04.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is Allowed. No costs.
