ORDER

This Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct Cultural Programme (Adal Padal Nigalchi) in the event of Mathampathi Village Arulmigu Sree Valiyamman Temple Festival at Pochampalli Taluk, Krishnagiri District on 24.05.2023 between 06.00 P.M to 11.00 P.M by considering the petitioner's representation dated 24.04.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of ***Mathampathi Village Arulmigu Sree Valiyamman Temple Festival at Pochampalli Taluk, Krishnagiri District on 24.05.2023 between 06.00 P.M to 11.00 P.M, the petitioner has sent a representation dated 24.04.2023*** to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner dated 24.04.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is Allowed. No costs.
