The Writ Petition has been filed to direct the respondent authority to give permission to conduct a cultural program schedule to be held on 14.05.2023 in “Sri Kaaliamman Chariot Festival”, at about 6 p.m. to 11 p.m at Reddypatti Village, Uthangarai Taluk, Krishnagiri District by considering the petitioner representation dated 02.05.2023.
