ORDER

This Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct the cultural event viz., Adal Padal (Song and Dance) program to be held on 22.05.2023 between 06.00 PM to 11.00 PM in connection with the Temple Festival of **Sri Maariyamman Temple situated at Periyagopannapalli Village, Karadikollapatti, Puligunta, Krishnagiri District – 635 203** by considering the petitioner's representation dated 02.05.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **02.05.2023** and pass suitable orders based on the above said circular.
