ORDER

This Writ Petition has been filed to direct the respondent to consider the petitioner's representation dated 24.04.2023 and grant permission to conduct the cultural program (Adal Padal Nigalchi), scheduled to be held on 24.05.2023 from 6 P.M. to 11 P.M., in Sri Mariyamman Temple situated at A.K. It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **24.04.2023** and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is Allowed. No costs.
