This Writ Petition has been filed to direct the respondent to give permission and police protection to conduct the cultural programme (Adal Padal Nigalchi) in the event of Murungapatti Village Arulmigu Sree Muthu Mariyamman Temple Festival at Salem Taluk & District on 28.05.2023 from 6 P.M. to 11 P.M., by considering the petitioner's representation dated 02.05.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in in the event of ***Murungapatti Village Arulmigu Sree Muthu Mariyamman Temple Festival at Salem Taluk & District on 28.05.2023 between 6 P.M. and 11 P.M., the petitioner has sent a representation dated 02.05.2023*** to the respondent. It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **02.05.2023** and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is Allowed. No costs.
