ORDER

This Writ Petition has been filed to direct the respondents to grant permission to conduct the cultural programme of Adal Padal on 17.05.2023 from 06.00 PM to 11.00 PM at "Sri Gengaimamman Temple Festival" Potharai Village, Potharai Post, Polur Taluk, Tiruvannamalai District, by considering the petitioner's representation dated 04.05.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme of Adal Padal in the event of "***Sri Gengaimamman Temple Festival***" at ***Potharai Village, Potharai Post, Polur Taluk, Tiruvannamalai District, on 17.05.2023 between 06.00 PM and 11.00 PM, the petitioner has sent a representation dated 04.05.2023*** to the respondents. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondents Police are hereby directed to consider the representation of the petitioner, dated **04.05.2023** and pass suitable orders based on the above said circular.
