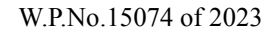

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of *Arulmighu Sri Muthumariyamman Thirukovil Festival at Kallakurichi District, Chinnasalem Taluk, Poosapadi Village on 14.05.2023*, the petitioner has sent a representation dated 03.05.2023 to the respondent. But, the same has not been considered so far. Hence, the present Writ Petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **03.05.2023** and pass suitable orders based on the above said circular.
