## ORDER

The Writ Petition has been filed to direct the respondents to grant permission to conduct a cultural programme of Adal Padal on 03.06.2023 at 06.00 PM to 11.00 PM at “Sri Mariamman Temple Festival” Veerachikuppam Village, Kallavi Post, Uthangarai Taluk, Krishnagiri District by consider and pass orders on the representation dated 29.04.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme on 03.06.2023 at 06.00 PM to 11.00 PM at “Sri Mariamman Temple Festival” Veerachikuppam Village, Kallavi Post, Uthangarai Taluk, Krishnagiri District, the petitioner has sent a representation dated 29.04.2023 to the respondents. But, the same has not been considered so far. Hence, the present writ petition has been filed.



3. The learned Government Advocate (Crl.side) appearing for the respondents submitted that the respondents police have received the representation of the petitioner and the same is pending for consideration.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 29.04.2023 and pass suitable orders based on the above said circular.
