ORDER

This Writ Petition has been filed to direct the respondents to grant permission to conduct the cultural programme of Adal Padal on 17.05.2023 from 06.00 PM to 11.00 PM at “Sri Mariamman Temple Festival” Narayanapuram Village, Perumapattu Post, Tiruppattur Taluk, Tiruppattur District, by considering the petitioner's representation dated 04.05.2023.
