This Writ Petition has been filed to direct the respondent to give permission and police protection to conduct the cultural programme viz., (Adal Padal) at Salem District, Attur Taluk, Paithur Village, Paithur 1st Ward Arulmighu Sri Mariyamman Thirukovil Festival on 24.05.2023, by considering petitioner's representation dated 26.04.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of 1st Ward Arulmighu Sri Mariyamman Thirukovil Festival, Salem District, Attur Taluk, Paithur Village, Paithur on 24.05.2023, the petitioner has sent a representation dated 26.04.2023 to the respondent.
