ORDER

This Writ Petition has been filed to direct the first and second respondents to grant permission to conduct the cultural programme of Adal Padal on 23.05.2023 at 06.00 P.M to 11.00 P.M at Sri Mariamman Temple Festival at Meduhalli Village, Mallikuttai Post, Karimangalam Taluk, Dharmapuri District by considering the petitioner's representation dated 29.04.2023 and pass orders on the same, within the time frame as may be fixed by this Court.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of ***Sri Mariamman Temple Festival at Meduhalli Village, Mallikuttai Post, Karimangalam Taluk, Dharmapuri District on 23.05.2023 between 06.00 P.M to 11.00 P.M, the petitioner has sent a representation dated 29.04.2023*** to the

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondents are hereby directed to consider the representation of the petitioner dated 29.04.2023 and pass suitable orders based on the above said circular.
