ORDER

This Writ Petition has been filed to direct the respondent authority to give permission to conduct Cultural Programme (Adalpadal) at Salem District, Gangavalli Taluk, Veppampoondi Village, Arulmighu Sri Sadaiyappar Thirukovil Festival on 23.05.2023 by considering the petitioner's representation dated 26.04.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme in the event of ***Arulmighu Sri Sadaiyappar Thirukovil Festival at Veppampoondi Village, Gangavalli Taluk, Salem District on 23.05.2023, the petitioner has sent a representation dated 26.04.2023*** to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner dated 26.04.2023 and pass suitable orders based on the above said circular.
