In view of the specific bar under Section 18 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and also taking into consideration of the facts of the case, there shall be a direction to the Special Court for S.C & S.T Act Cases, Villupuram to consider the petitioner's bail application on the same day of his surrender in connection with Crime No.54 of 2023 registered for the offence under Sections 294(b), 379, 448, 427, 506(II) IPC and Sections 3(1)(g), 3(1)(r), 3(1)(s) and 3(2)(Va) of the S.C & S.T Act, on the file of the respondent and pass appropriate orders in accordance with law.
