WEB COPY This Writ Petition has been filed for directing the respondent to give permission and Police Protection to the petitioner to conduct a Cultural Programme (Adal Padal Nigalchi) in the event of Shri Mariamman Temple Festival at Goundappanur Village, Sevvathur Post, Thirupattur Taluk, Thirupattur District-635654 on 31.05.2023 by considering the petitioner's representation dated 06.05.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 06.05.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is Allowed. No costs.
