This Writ Petition has been filed for directing the first and second respondents to grant permission to conduct the cultural programme of Adal Padal on 24.05.2023 at 6.00 pm to 11.00 pm at “Sri Mahamariamman Temple Kumbhabhishekam festival” Nochikulam Village, Nochikulam Post, Kunnam Taluk, Perambalur District by consider and pass orders on the representation dated 04.05.2023 made by the petitioner.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Mahamariamman Temple Kumbhabhishekam festival” Nochikulam Village, Nochikulam Post, Kunnam Taluk, Perambalur District on 24.05.2023 at 6 P.M to 11 P.M, the petitioner has sent a representation dated 04.05.2023 to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 04.05.2023 and pass suitable orders based on the above said circular.
