ORDER

This Writ Petition has been filed to direct the respondents to grant permission to conduct the cultural programme of Adal Padal at "Sri Mariamman Temple Festival" Kothakottai Village, Kothakottai Post, Vaniyambadi Taluk, Tiruppattur District, on 23.05.2023 from 06.00 PM to 11.00 PM, by considering the petitioner's representation dated 04.05.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondents Police are hereby directed to consider the representation of the petitioner, dated **04.05.2023** and pass suitable orders based on the above said circular.
