survey the petitioner's land in S.No.195/212A to an extent of 4 cents, situated at Melsomaarpettai Village, Payanapalli, Krishnagiri Taluk, Krishnagiri District with the aid of police based on the application of the petitioner dated 17.04.2023.

ORDER

Mr.A.M.Ayyadurai, learned Government Advocate, accepts notice for respondents 1 to 4.

2. In light of the order that is proposed to be passed, no notice is necessary at this juncture to private respondents, who are arrayed as respondents 5 to 7.

3. The petitioner seeks a mandamus directing the third respondent being the Tahsildar, Krishnagiri Taluk to survey the land at S.No.195/212A admeasuring 4 cents situated at Melsomaarpettai Village, Payanapalli, Krishnagiri Taluk, Krishnagiri District, the land in question.

4. In fact, the petitioner has also made an application on 17.04.2023 to an identical effect.

5. Mr.A.M.Ayyadurai, learned Government Advocate, who accepts notice for the official respondents would convey that the respondents have no objection to mandamus being issued as sought for.

6. Hence, mandamus is issued to the third respondent to survey the land in question after issuing notice to the petitioner as well as private respondents. Since the petitioner is a senior citizen, let this exercise be completed within a period of eight (8) weeks from the date of receipt of a copy of this order.

Accordingly, this Writ petition is disposed of. No costs.
