ORDER

This Writ Petition has been filed to direct the first and second respondents to grant permission to conduct the cultural programme of Adal Padal on 30.05.2023 at 06.00 PM to 11.00 PM at "Sri Gengaiamman Temple Festival" Senur Village, Senur Post, Katpadi Taluk, Vellore District by consider and pass orders on the representation dated 29.04.2023 made by the petitioner within the time frame as may be fixed by this Hon'ble Court.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of "***Sri Gengaiamman Temple Festival***" ***Senur Village, Senur Post, Katpadi Taluk, Vellore District on 30.05.2023 between 06.00 P.M and 11.00 P.M, the petitioner has sent a representation dated 29.04.2023*** to the respondent. But, the same

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to
