ORDER

This Writ Petition has been filed to direct the first and second respondents to grant permission to conduct the cultural programme of Adal Padal on 25.05.2023 from 06.00 PM to 11.00 PM at "Sri Mariamman Temple Festival" Manchinaickanahalli Village, Manchinaickanahalli Post, Pennagaram Taluk, Dharmapuri District by considering the petitioner's representation dated 04.05.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **04.05.2023** and pass suitable orders based on the above said circular.
