ORDER

This Writ Petition has been filed to direct the first and second respondents to grant permission to conduct the cultural programme of Adal Padal on 25.05.2023 from 06.00 PM to 11.00 PM at "Sri Kaliamman Temple Festival" Rasampatti Village, Valathur Post, Gudiyatham Taluk, Vellore District by considering the petitioner's representation dated 04.05.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of "**Sri Kaliamman Temple Festival**" Rasampatti Village, Valathur Post, Gudiyatham Taluk, Vellore District, *on 25.05.2023 between 06.00 P.M and 11.00 P.M, the petitioner has sent a representation dated 04.05.2023* to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **04.05.2023** and pass suitable orders based on the above said circular.
