The Writ Petition has been filed to direct the respondent to give permission to conduct the Cultural Programme (Adal Padal Nigalchi) in the event of Noothappur Village Arulmigu Sree Azhagu Muthu Mariyamman Temple Festival at Veppanthattai Taluk, Perambalur District on 14.05.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 06.05.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme on 14.05.2023 from 06.00 PM to 11.00 PM in Arulmigu Sree Azhagu Muthu Mariyamman Temple Festival at Veppanthattai Taluk, Perambalur District, the petitioner has sent a representation dated 06.05.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. The learned Additional Public Prosecutor appearing for the

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 06.05.2023 and pass suitable orders based on the above said
