PRAYER: Original Petition filed for Succession Certificate under Section 372 of Indian Succession Act, 1925 under Order XXV Rule 6 of Original Side Rules, prays that a Succession Certificate may be granted in favour of the Petitioners with powers to collect the securities and to receive the interest and dividends on/ and negotiate and transfer the securities as specified in the schedule annexed hereto.

ORDER

The petitioners seek Succession Certificate in respect of the securities held by Shalini Rajan, who died intestate on 29.09.2020. The first and second petitioners are the daughters and the third petitioner is the son of the deceased Shalini Rajan.

2. The third petitioner has been examined as P.W.1. He has produced the death certificates of the deceased Shalini Rajan and Rajan Athmaram (father of the petitioners), as Exs.P1 and P2. The legal heirship certificate of the deceased

Shalini Rajan as Ex.P3. A perusal of Ex.P3 shows that the petitioners are the only legal heirs of the deceased. A paper publication has been made and any objections have not been received.

3. In view of the above said evidence, the Original Petition is allowed by granting Succession Certificate in favour of the petitioners in respect of the securities mentioned in the schedule to the petition.
