2. It is stated that the Chief Educational Officer, Thiruvallur District/4th respondent herein had recommended appointing the petitioner on compassionate grounds. This was by proceedings dated 28.01.2020.

3. A direction is given that if steps are taken to fill up vacant posts, the petitioner should also be considered on compassionate grounds, if she is otherwise eligible and if she satisfies necessary qualifications, then she should be posted in accordance with her educational qualification, if there is a post vacant and in accordance with the Rules and Regulations. If there is a post vacant, within a reasonable period of time, the petitioner may be accommodated in the said post on compassionate grounds.

4. With the above direction to the respondents, the writ petition stands disposed of. No costs. Connected W.M.P. is closed.
