2.The petitioners had given a representation on 19.04.2023. The petitioners seeking such restraint from interference till disposal of O.S.No.80 of 2022 which is now pending on the file of the learned Principal District Judge – II, Kancheepuram. In the said suit, the Talshildar, Kancheepuram, the Revenue Divisional Officer, Kancheepuram and the District Revenue Officer, Kancheepuram and also the District Collector, Kancheepuram, are defendants. Necessary injunction order can be sought by the petitioners from the said suit itself and filing of Writ Petition couching it in the nature of Mandamus seeking consideration of a representation cannot be entertained by this Court.

3.Accordingly, this Writ Petition stands dismissed. No costs. Consequently, connected Writ Miscellaneous Petition is closed.
