The detenu has been detained by the second respondent by his order in BCDFGISSSV No.86/2022, dated 19.05.2022, holding him to be a "Goonda", as contemplated under Section 2(f) of Tamil Nadu Act 14 of 1982. The said order is under challenge in this Habeas Corpus Petition.
