When the writ petition is taken up, Mr.S.Prabhakaran, learned Government Advocate, on instructions, submits that only the encroachments on the bund have been removed and there is no proposal to remove the bund situated at Survey No.50 in Akkichettipalayam Village, as apprehended by the petitioner.

3. This Court records the aforesaid submission made by learned Government Advocate. That apart, there is no cause of action for filing the present writ petition, as the apprehension of the petitioner is unfounded.

4. The writ petition is disposed of accordingly. There will be no order as to costs. Consequently, W.M.P.No.15597 of 2023 is closed.
