We have heard Mr.T.Balaji, learned counsel for the petitioner and Mr.K.Sathishkumar, learned standing counsel for respondents 1, 3 and 4 so also Mr.P.Muthukumar, learned State Government Pleader, for the second respondent.

2. The petitioner contends that the petitioner has filed an objection (at Page 30 of the paper book) with the Collector regarding

5. The parties may take further steps pursuant to the order that may be passed by the Collector on the objection raised by the petitioner. The interim order passed by this Court shall come to an end the moment the Collector passes the order.

The writ petition is disposed of. There will be no order as to costs. Consequently, connected miscellaneous petition is closed.
