ORDER

This Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Samiyarpettai Village Arulmigu Sree Pinnaivali Amman Temple Festival at Bhuvanagiri Taluk, Cuddalore District on 04.06.2023 at 06.00 PM to 11.00 PM by considering the petitioner's representation dated 23.05.2023.

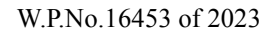
the respondent. But, the same has not been considered so far. Hence, the

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **23.05.2023** and pass suitable orders based on the above said circular.
