ORDER

This Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Pichankottagam Vadapathi Arulmigu Sree Batharakaliyamman, Kathavarayan & Agni Veeran Temple Festival at Thiruthuraipoondi Taluk, Tiruvarur District on 02.06.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 23.05.2023.
