This Writ Petition has been filed to direct the respondent to give

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of **Sri Mariamman Temple, Valli Maduram Village, Thittagudi Taluk, Cuddalore District on 06.06.2023 at 06.00 P.M onwards, the petitioner has sent a representation dated 29.05.2023** to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.
