This Writ Petition has been filed to direct the first and second respondents to grant permission to conduct the cultural programme of Adal Padal on 03.06.2023 at 06.00 PM to 11.00 PM at "Sri Mariamman Temple Festival" Kottur Colony, Vizhudhonipalayam Post, Gudiyatham Taluk, Vellore District by consider and pass orders on the representation dated 19.05.2023 made by the petitioner within the time frame as may be fixed by this Hon'ble Court.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **19.05.2023** and pass
