This Writ Petition has been filed to direct the respondents to consider the representation of the petitioner dated 08.09.2020 and to initiate appropriate action against the respondents 4 to 6 herein for the illegal and unauthorized erection of shop in front of the property of the petitioner.

The case of the petitioner is that the respondents 4 to 6 have erected permanent shop in front of the petitioner's house thereby affecting the flow of traffic as well as free flow of ingress and egress to her property.
