ORDER

This Contempt Petition has been filed to punish the respondents for non compliance of the order dated 04.01.2022 passed by this Court in W.P.No.28329 of 2021, thereby directing the respondents to pay compensation amount that was already agreed to the petitioners.

The learned Government Advocate appearing for the respondents submitted that as directed by this Court, by an order dated 04.01.2022 in W.P.No.28329 of 2021, the second respondent conducted enquiry in order to disburse the compensation amount. However four persons were claiming the compensation amount for the very same land. Therefore, though the respondents are ready to disburse the compensation amount, there are rival
