2.The writ petition has been filed, seeking for a direction to the first respondent to approve the appointment of the petitioner as Pre School Aya, in the third respondent Special School for Hearing Impaired, with effect from 05.04.2022, with all consequential and other monetary benefits, within the time frame fixed by this Court.

3.This Court may not be justified in stepping into the shoes of the respondents for not considering such a prayer made by the petitioner. Nevertheless if the first respondent is directed to consider the proposal dated 05.04.2022 made by the third respondent, within a stipulated time, the ends of justice would be secured.
