It is submitted by the learned counsel for the petitioner that the petitioner has filed O.S.No.426 of 2010, seeking specific performance of agreement of sale and the same was decreed on 19.08.2015. He filed E.P.No.1 of 2022 in O.S.No.426 of 2010, seeking execution of the decree.
