Prayer: Writ Petition filed under Article 226 of the Constitution of India for issuance of a Writ of Certiorarified Mandamus, to call for the records pertaining to the orders dated 11.10.2013 passed by the then Chief Minister under endorsement No.3865/drmd/c3/2012 at page 39 of the Note File No.SCR/ GLR/C1/2012 dated 21.05.2012 and pertaining to the memorandum



dated 24.09.2016 made in No.10369/DRDM/ C3/2016-17 of the Inspector General of Registration, Puducherry, 2nd respondent herein, and consequential implementation of those orders by the 3rd respondent quash the same and direct the respondents to fix the GLR notionally for the year 2016-2017 on percentile basis, treating the GLR value fixed for the year 2012-13 as base and by adding 10 or 20% year after year i.e 2013-14, 2014-15, 2015-16 and 2016-17.
