In Crl.O.P.No.13008 of 2003, the petitioner, who apprehends arrest at the hands of the respondent/ Police for the offence punishable under Section 379 IPC in Crime No. 72 of 2023, seeks anticipatory bail.

2. **In Crl.O.P.No.13038 of 2023**, the petitioner, who apprehends arrest at the hands of the respondent/ Police for the offence punishable under Section 379 IPC in Crime No. 59 of 2023, seeks anticipatory bail.

3. **In Crl.O.P.No.13041 of 2023**, the petitioner, who apprehends arrest at the hands of the respondent/ Police for the offence punishable under Section 379 IPC in Crime No. 13 of 2023, seeks anticipatory bail

4. **In Crl.O.P.No.13005 of 2023**, the petitioner, who apprehends arrest at the hands of the respondent/ Police for the offence punishable under Section 379 IPC in Crime No. 11 of 2023, seeks anticipatory bail

5. In **Crl.O.P.No.13058 of 2023**, the petitioner, who apprehends arrest at the hands of the respondent/ Police for the offence punishable under Section 379 IPC in Crime No.73 of 2023, seeks anticipatory bail.

6. The case of the prosecution in **Crl.O.P.No.13008 of 2023** as per the defacto complainant Junior Engineer, TNEB, Poondi village is that on 31.01.2023, the electrical wire approximately 2080 metres worth about 1,00,000/- was found missing. Hence the complaint.

7. The case of the prosecution in **Crl.O.P.No.13038 of 2023** as per the defacto complainant Junior Engineer, TNEB, Poondi village is that on 12.02.2023, the electrical wire approximately 2420 metres worth about Rs.1,14,000/- was found missing. Hence the complaint.

8. The case of the prosecution in **Crl.O.P.No.13041 of 2023** as per the defacto complainant Junior Engineer, TNEB, Poondi village is that on 10.01.2023, the electrical wire approximately 250 metres was found missing. Hence the complaint.

9. The case of the prosecution in **Crl.O.P.No.13005 of 2023** as per the defacto complainant Junior Engineer, TNEB, Poondi village is that on 01.01.2023, the electrical wire approximately 1500 metres was found missing. Hence the complaint.

10. The case of the prosecution in **Crl.O.P.No.13058 of 2023** as per the defacto complainant Junior Engineer, TNEB, Poondi village is that on 02.02.2023, the electrical wire approximately 2000 metres worth about Rs.98,000/- was found missing. Hence the complaint.

11. The learned counsel for the petitioner submitted that the petitioner is an innocent person and he has not committed any offences as alleged by the prosecution and that he has been falsely implicated in this case based on the confession given by the co-accused. He further submit that the petitioner is a contractual labour and A1 has been granted anticipatory bail by this Court in Crl.O.P.No.12222 of 2023 vide order dated 26.05.2023. Hence, he prays for grant of anticipatory bail to the petitioner.

12. The learned Government Advocate (Criminal Side) appearing for the respondent submitted that the petitioner along with other accused committed theft of electricity line approximately approximately **1780** metres about Rs.**1,98,000/-**. Hence, he opposed for grant of anticipatory bail to the petitioner.

13. Heard both sides and perused the materials available on record including the FIR.

14. Taking into consideration the facts and circumstances of the case, this Court is inclined to grant anticipatory bail to the petitioner with certain condition.

15. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his appearance, within a period of fifteen days from the date on which the order copy made ready, before the **learned Judicial Magistrate No.I, Thiruvallur** on condition that the each of the petitioners shall execute a bond for a sum of **Rs.10,000/- (Rupees Ten**

thousand only) with two sureties each for a like sum to the satisfaction of the respondent/Police or the police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned, failing which, the petition for anticipatory bail shall stand dismissed and on further condition that :

[a] the petitioner and the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate/trial Court may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

[b] the petitioner shall report before the Vengal Police Station every day at 10.30 a.m., and also shall report before the Pullarambakkam Police Station at 6.30 pm until further orders.

[c] the petitioner shall not tamper with evidence or witness either during investigation or trial;

[d] the petitioner shall not abscond either during investigation or trial;



[e] Breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioners released on bail by the learned Magistrate/Trial Court, as laid down by the Hon'ble Supreme Court in ***P.K.Shaji Vs. State of Kerala [(2005) AIR SCW 5560]***; and;

[f] if the petitioner herein thereafter absconds, a fresh FIR can be registered under Section 229-A IPC.

16. Accordingly, the Criminal Original Petitions are ordered.
