Prayer in W.P. No. 17694 of 2022:- Writ Petition filed under Article 226 of the Constitution of India, 1950, praying to issue a Writ of Certiorarified Mandamus, calling for the records relating to the Order dated 06.10.2020 in P-I/SIGC-P/Chemax/2015 and letter dated 28.03.2022 issued by the First Respondent in Lr.No. P-II/SIP-Perun./Chemax/2015 and quash the same and consequently direct the First Respondent to grant extension of time to the Petitioner to implement the project for the reasons above stated.

Prayer in W.P. No. 17701 of 2022:- Writ Petition filed under Article 226 of the Constitution of India, 1950, praying to issue a Writ of Certiorarified Mandamus, calling for the records relating to the Order dated 15.09.2017 and letter dated 28.03.2022 issued by the First Respondent in Lr.No. P-II/SIP-Perun./Thangamuthu/2015 and quash the same and consequently direct the First Respondent to grant extension of time to the Petitioner to implement the project for the reasons above stated.
